By accepting this Eagle Valley Snowmobile Club Membership, I agree to save harmless and keep indemnified the Province of BC, any landowner from which the E.V.S.G.S's (Eagle Valley Snowmobile Grooming Society) & E.V.S.C.'s (Eagle Valley Snowmobile Club) trail operates and the E.V.S.C. and the E.V.S.G.S., its members, directors, officers, employees, and their respective agents, officials, servants, and representatives from and against all claims, actions, costs and expenses and demands in respect to death, injury, loss or damage to my person or property or to the person or property of any driver or passenger operating the aforementioned permitted snowmobile, however caused, arising out of or in connection with the use of the Sicamous Trail System, notwithstanding that the same may have been contributed to or occasioned by the negligence of said bodies, or any of them, their agents, officials, servants, or representatives. It is further understood and agreed that this agreement is binding upon myself, my heirs, executors, administrators and assigns.

I hereby expressly waive any and all claims I may have and hereby expressly release from liability the Province of BC, the A.B.C. (Association of British Columbia Snowmobile Clubs), E.V.S.C. and E.V.S.G.S., their members, their employees, agents, representatives and contractors for any loss or damage to property or personal injury, including death, which I may suffer or be subject to as a result of my participation in activities on Province of BC, A.B.C., or E.V.S.C. or E.V.S.G.S. trails or property, arising out of any cause whatsoever, including without limitation, the negligence of the Province of BC. or A.B.C. or E.V.S.C. or E.V.S.G.S., or any of said members, employees, agents, representatives or contractors.

I am aware that snowmobiling presents certain dangers and I accept full responsibility for the risks inherent in such an endeavor. Such dangers include but are not restricted to travelling into mountainous or forested terrain which in their natural state present many obstacles and hazards.
